Professor Judith Green - Keynote

Judith Green is Professor of Sociology in the department of Social & Political Sciences, Philosophy & Anthropology at the University of Exeter, where her research focuses on sociology of public health, methodology and mobility. She is the co-editor of *Journal of Critical Public Health*, a diamond open access journal which launched in 2024.

Dr Sacha Jones is Head of Open Research Services at Cambridge University Libraries and heads the team in the Office of Scholarly Communication providing services, support and advocacy to the University's research community. These focus on open research practices and policies, research data management, research skills training, academic community engagement and public dissemination of scholarly outputs.

Dr. Samuel A Moore is the Scholarly Communication Specialist at Cambridge University Library and Principal Investigator of Materialising Open Research Practices in the Humanities and Social Sciences (funded by Wellcome Trust, AHRC and the Research England Development Fund). He is also an Affiliated Lecturer at Cambridge Digital Humanities and a College Research Associate at King's College Cambridge.

Jack Graveney is Managing Editor at *The Cambridge Journal of Law, Politics, and Art*. Having taken his BA at Cambridge in 2022 and MSt at Oxford in 2024, he will begin a PhD in History at Jesus College this October.

Liam McClain is the Editor-in-Chief and former founding Biological Anthropology Managing Editor at the *Cambridge Journal of Human Behaviour (CJHB)*. He holds a BA in Archaeology from Cambridge and recently completed an MSc in Cognitive and Evolutionary Anthropology at the University of Oxford.

Dr Catherine Hills is an archaeologist specialising in the early medieval period in Britain and Europe. For many years she was a senior lecturer in the department of archaeology,

University of Cambridge. Since retirement in 2014 she has edited the journal of the Cambridge Antiquarian Society, known as PCAS - Proceedings of the Society.

Dr Agustina Martínez García leads the Open Research Systems Team within Cambridge University Library. She leads the development of the Open Research Infrastructure roadmap that is part of a wider Open Research Programme led by Cambridge University Libraries. She is also responsible for the development of Cambridge's Institutional Repository, Apollo, and integrations with other systems and services to support researchers making their research outputs available in ways that enable greater discoverability and re-use.

Emily Marchant is Head of Strategic Projects in the Academic publishing division at Cambridge University Press and Assessment, and works with a range of colleagues to work on support for alternative publishing models including diamond.

Caroline MacKay is a licensing manager at Jisc and is currently working on the equitable licensing workstream highlighting and promoting best practice in equitable pricing and licensing models. She worked on the initial Open Access Community Framework initiative in 2022 and negotiated a number of Diamond OA monograph agreements as part of the work supporting the implementation of the UKRI monographs policy.

Mark Huskisson is the strategic development advisor to the Public Knowledge Project and the Co-Chair of the Assembly of the Commons for OPERAS, the Research Infrastructure supporting open scholarly communication in the social sciences and humanities in the European Research Area, and a Diamond Open Access advisor to Science Europe and the Canadian Research Knowledge Network. He has over thirty years of academic publishing experience and works with the global scholarly communications community to establish knowledge as a public good.
